

ANNEXURE**APPOINTMENT OF DIRECTOR (FINANCE) IN CENTRE FOR RAILWAY INFORMATION SYSTEMS (CRIS)**

Centre for Railway Information Systems (CRIS) is an organization under Ministry of Railways. CRIS is a unique combination of competent IT professionals and experienced Railway personnel enabling it to deliver complex Railway IT systems in core areas.

Applications are invited for the post of **Director (Finance)** in CRIS as per details given below:

(1) Pay Scale: Rs.1,82,200-2,24,100/-(with Central DA) in Level 15 of the 7th CPC Pay Matrix.

(2) **Mode of appointment:** Absorption/Deputation/Direct Recruitment

(3) **Method of recruitment:**

The post shall be filled by the method of selection by a Search-cum-Selection Committee (SCSC).

(4) **Employment status:**

The applicant must, on the date of application, as well as on the date of interview/personal interaction (if any), be employed in a regular capacity —and not in a contractual/ad-hoc capacity —in one of the following:

- (a) Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);
- (b) Central Government including the Armed Forces of the Union and All India Services;
- (c) StatePublicSectorEnterprise(SPSE)wheretheannualturnoveris*Rs1000 crore or more;
- (d) Private Sector company where the annual turnover is *Rs. 1000 crore or more. Preference would be given to candidates from listed Companies.

(*The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered)

(5) **Qualification:**

- (i) Bachelors Degree in Commerce/Accounting/Finance with a good academic record from recognized University or Masters/MBA in Finance/Chartered Accountant/Cost Accountant.

(ii) Applicants from the Central Government/ Armed Forces of the Union /All India Services will be exempted from the educational qualification as per (i) above provided the applicants have the relevant experience as mentioned in Para 6(i) below for Director/Finance.

(6) Experience:

(i) Applicants from Central Government/Armed Forces of the Union/All India Services should possess adequate experience at a senior level of management in a large organization of repute. Academic background and Professional experience and exposure to Financial Management, Accounting and dealing with financing institutions, would be given due weightage during selection.

(ii) Applicants from CPSEs/SPSEs/Private Sector should possess minimum 20 years of experience in the area of Financial Systems and Accounting of which at least 3 years should be at senior management level in commercial accounting/company accounts and experience in dealing with tenders/contracts during the preceding ten years.

(7) Eligible Pay Scales:

(i) Applicants from Central Government/All India Services should be holding a post of the level of Joint Secretary in Government of India or carrying equivalent scale of pay on regular basis on the date of application.

(ii) Applicants from the Armed Forces of the Union should be holding a post of the level of Major General in the Army or equivalent rank in Navy/Air force on the date of application.

(iii) Applicants from CPSEs should be working in the scale of pay of Rs. 51,300-73,000/-(IDA—post 01.01.2007) or Rs.1,20,200-2,80,000/-(IDA post 01.01.2017) or higher.

(iv) Applicants from Autonomous Bodies/Societies under the Central/State Government in SAG equivalent grade/pay scale on regular basis or higher would be eligible.

(v) Applicants from the State Public Sector Enterprises /Private Sectors should be working at Board level position or at a post immediately below the Board level on the date of application.

(vi) Government officers working on deputation in PSUs/autonomous bodies etc. would be treated at par with their peers in the parent cadre and on the basis of their substantive grade/pay scale in the parent cadre.

(8) Age Limit: Not more than 56 years for internal candidates and 55 years for others as on the closing date of the Vacancy Notice.

(9) Period of Appointment:

The period of appointment shall be 5 years or till the officer attains the age of superannuation, whichever is earlier. The age of superannuation will be 60 years.

(10) Extension of tenure:

Authority to approve extension of tenure will vest in the Hon'ble Minister of Railways.

(11) Note:

(a) Applicants would be required to submit applications in the prescribed format and state in detail the work done and experience gained in the relevant field. They would also be required to submit documents in support of their eligibility.

(b) Applicants from Government Service, Public Sector Undertakings and Autonomous Bodies/ Societies will be required to submit their applications through proper channel along with relevant documents including service certificate and attested copies of APARs.

रेलवे सूचना प्रणाली केंद्र (क्रिस) में निदेशक (वित्त) की नियुक्ति

रेलवे सूचना प्रणाली केंद्र (क्रिस) रेल मंत्रालय के अधीन आने वाला एक संस्थान है। क्रिस सक्षम सूचना प्रौद्योगिकी पेशेवरों और अनुभवी रेल कर्मियों का एक अद्वितीय संयोजन है, जो आधारभूत क्षेत्रों में जटिल रेलवे सूचना प्रौद्योगिकी प्रणाली को प्रदान करने में सक्षम बनाता है।

क्रिस में **निदेशक (वित्त)** के पद के लिए नीचे दिए गए विवरण के अनुसार आवेदन आमंत्रित किए जाते हैं:

(1) **वेतनमान** : 7 वें केंद्रीय वेतन आयोग वेतन मैट्रिक्स के लेवल 15 में 1,82,200-2,24,100/- रु. (केंद्रीय महंगाई भत्ता सहित)।

(2) **नियुक्ति की विधि** : समाहन/प्रतिनियुक्ति/सीधी भर्ती

(4) निजी क्षेत्र की कंपनी जहां वार्षिक टर्नओवर *1000 करोड़ रु. या उससे अधिक है। सूचीबद्ध कंपनियों के उम्मीदवारों को प्राथमिकता दी जाएगी।

(*जिस कैलेंडर वर्ष में पद का विज्ञापन किया गया है, उससे पहले के तीन वित्तीय वर्षों के औसत लेखापरीक्षित वार्षिक टर्नओवर को माना जाएगा)

(5) **अर्हता:**

(i) किसी भी मान्यताप्राप्त विश्वविद्यालय से अच्छे शैक्षणिक रिकॉर्ड के साथ कॉमर्स/अकाउंटिंग/फाइनेंस में स्नातक डिग्री अथवा चार्टर्ड अकाउंटेंट/कॉस्ट अकाउंटेंट/ फाइनेंस में स्नातकोत्तर/एमबीए।

(ii) केंद्र सरकार/संघ के सशस्त्र बलों/अखिल भारतीय सेवाओं के आवेदकों को उपरोक्त (i) में दी गई शैक्षिक अर्हता से छूट प्राप्त होगी बशर्ते आवेदकों को निदेशक/वित्त के लिए नीचे दिए गए पैरा 6(i) में यथा-उल्लिखित संगत अनुभव रखते हो।

(6) **अनुभव:** (i) केन्द्र सरकार/संघ के सशस्त्र बलों/अखिल भारतीय सेवाओं के आवेदकों के पास प्रतिष्ठित बड़े संगठनों में प्रबंधन के वरिष्ठ स्तर पर पर्याप्त अनुभव होना चाहिए। चयन के दौरान शैक्षणिक पृष्ठभूमि

और व्यावसायिक अनुभव, साथ ही वित्तीय प्रबंधन, लेखांकन और वित्तीय संस्थानों के साथ कार्य करने के अनुभव को वरीयता दी जाएगी।

(ii) सीपीएसई/एसपीएसई/निजी क्षेत्रों के आवेदकों के पास वित्तीय प्रणाली और लेखांकन के क्षेत्र में 20 वर्ष का न्यूनतम अनुभव होना चाहिए, जिसमें से पिछले दस वर्षों के दौरान कम-से- कम 3 वर्ष का अनुभव वाणिज्यिक लेखांकन/कम्पनी लेखा और निविदाओं/संविदाओं का निष्पादन करने में वरिष्ठ प्रबंधन स्तर पर होना चाहिए।

(7) पात्र वेतनमान:

(i) केन्द्रीय सरकार/अखिल भारतीय सेवाओं के आवेदकों के पास आवेदन की तारीख को भारत सरकार में संयुक्तसचिव स्तर के पद पर नियुक्त होने चाहिए अथवा नियमित आधार पर उसके समतुल्य वेतनमान पर कार्यरत हों।

(ii) संघ के सशस्त्र बलों के आवेदकों के पास आवेदन की तारीख को थलसेना में मेजर जनरल के स्तर का पद अथवा नौसेना/वायुसेना में समकक्ष रैंक का पदधारक होना चाहिए।

(iii) सीपीएसई के आवेदक 51,300-73,000/- रुपए (आईडीए -01.01.2007 के बाद) अथवा 1,20,200-2,80,000/- रुपए (आईडीए- 01.01.2017 के बाद) अथवा उच्चतर वेतनमान पर कार्यरत होने चाहिए।

(iv) केन्द्र/राज्य सरकार के अधीन स्वायत्त निकायों/सोसाइटियों से वरिष्ठ प्रशासनिक ग्रेड के समतुल्य श्रेणी/नियमित आधार पर वेतनमान या उच्चतर ग्रेड के आवेदक पात्र होंगे।

(v) राज्य सार्वजनिक क्षेत्र के उद्यमों/निजी क्षेत्रों के आवेदकों को आवेदन की तारीख को बोर्ड स्तर के पद पर या बोर्ड से ठीक नीचे किसी पद पर कार्यरत होने चाहिए।

(8) आयु-सीमा : रिक्तिकी सूचना की अंतिम तारीख को आंतरिक उम्मीदवारों के लिए 56 वर्ष और अन्य उम्मीदवारों की आयु 55 वर्ष से अधिक न हो।

(9) नियुक्ति की अवधि: नियुक्तिकी अवधि 5 वर्ष होगी अथवा जब तक अधिकारी सेवानिवृत्ति की आयु प्राप्त नहीं कर ले, जो भी पहले हो। सेवानिवृत्ति की आयु 60 वर्ष होगी।

(10) कार्यकाल की अवधि का विस्तार : कार्यकाल की अवधि के विस्तार को मंजूरी देने का अधिकार माननीय रेल मंत्री को होगा।

(11) टिप्पण :

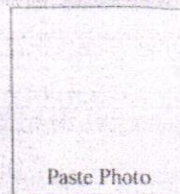
