Applicants who are not able to apply on the HRMS portal may apply in the prescribed application format, Annexure-I attached and may send their application to their administrative officer (HQ/Board etc.) for forwarding the application to Railway Board indicating No Objection, Vigilance/D&AR clearance, APARs for the last five years etc. In terms of Railway Board's letter No. 2018/E(O)II/41/1 dated 08.02.2023 & 13.04.2023 **all Zonal Railways/PUs are required to forward the applications received from IR officers for deputation to Railway Board well in advance, i.e. at least 07 days prior to the last date of vacancy notice for further consideration of the Competent Authority in Railway Board.
